Agenda item #8 - Consent Agenda:

The motion, provided no member chooses to pull individual matters described off the Consent Agenda, would be:

Move to approve the adoption of the resolutions as listed in agenda item #8.

Resolution No. 3-2019 – If adopted, 41.75 acres owned by Fredrick Irrevocable Trust, Section 36, Town of Moundville would be rezoned to AG-3(2) and the Farmland Preservation Overlay District.

Resolution No. 4-2019 – If adopted, authorization would be given for Patrick Kilbey, County Conservationist, to apply to the DNR for financial assistance for replacing the Lake Puckaway launch Dock.

Agenda Item #9 - Separate Consideration of Resolutions

Resolution No. 5-2019 – If adopted, would approve a budget amendment of up to \$40,000 for the purpose of correcting the Courtroom Audio-Video devices and software as per the recommendation of the MIS Director.

Resolution No. 6-2019 – If adopted, would authorize purchase of 3.09 acres, said land being near the Crossroads area Salt Shed property. This purchase will be from the Rodger brothers for \$77,500 which includes the previously approved \$50,000 plus \$27,500 for the additional acreage and the expense is to be from Highway Department Fund 29. This resolution replaces Resolution 51-2018.
