Sheriff Joe Konrath and Captain Les Crandall gave a PowerPoint presentation regarding the proposed contracting of police services to the City of Montello.

Resolution No. 1-2019 RESOLUTION TO APPROVE THE DEVELOPMENT OF A CONTRACT WITH THE CITY OF MONTELLO FOR POLICE SERVICES

(Introduced by Jon Sheller and Ken Borzick)

Upon roll call Resolution No. 1-2019 was adopted as follows: Ayes 15; Noes 0; Absent 2.

WHEREAS, the Mayor and City Council of the City of Montello has asked the Marquette County Sheriff's Office to provide police services by contract beginning when possible in 2019, and

WHEREAS, this is to be revenue/expense neutral to Marquette County meaning wages and fringes and overhead costs such as liability insurance will need to be reimbursed.

THEREFORE, BE IT RESOLVED, the Corporation Counsel, Sheriff and Administrative Coordinator are authorized to work out terms of a contract allowing for this provision of police services to the City of Montello with the understanding that this contract be brought back to County Board for authorization of signatures as it will exceed \$100,000, and

FURTHER, BE IT RESOLVED, Sheriff Konrath is authorized to increase the Patrol Deputy positions by two officers in order to provide said services, and in the event the contract with the City is terminated, the budget of the Sheriff's Office shall be reduced by the positions that were necessary to fulfill the contract with the City.

FURTHER, BE IT RESOLVED, another resolution amending the 2019 Sheriff budget on the expense and revenue side is to be brought to the County Board at the same time as the contract approval.

Motion/second by Nigbor/Locke to pay Joe Konrath at 50% of the sick leave hours as per personnel policy adopted June of 2016. There was discussion followed by motion/second by Nigbor/Krentz to withdraw the motion. Motion carried.

Motion by Nigbor to pay Joe Konrath at 50% of the sick leave hours. No second.

Motion/second by Fenner/Buchholz to pay Joe Konrath 75% of the sick leave hours as he transitions to an elected official no longer to be accumulating leave. Motion carried on a roll call vote as follows: Ayes 13; Noes 2; Absent 2.

Voting Yes: Borzick, Buchholz, Fenner, Gibeaut, Goldsmith, Krentz, Locke, Miller, O'Brien, Rosenthal, Sheller, Thalacker and Walters.

Voting No: Mack and Nigbor. Absent: McGwin and Raddatz.

Correspondence from the Department of Natural Resources naming the 2019 Fire Wardens was read. Motion/second by Walters/Locke to accept the Fire Wardens list and authorizing Board Chairperson Miller to sign same. Motion carried.

The fiscal and personnel reports were reviewed as presented by Administrative Coordinator Gary Sorensen. The monthly activity report of the Corporation Counsel was reviewed as presented by Natalie Bussan.

Calendar planning was reviewed for February meetings with notation of a correction to the calendar being there is no County Board meeting on February 12th.

The meeting was declared adjourned subject to the call of the Chairperson. The meeting adjourned at 8:16 p.m.
