MARQUETTE COUNTY**


Supervisors,

I report that from January 1, 2017 to December 31, 2017, in which I served as District Attorney for Marquette County, there was a sum of \$3,866.63 received by the District Attorney's Office for costs such as copy costs for discovery materials and \$37,254.96 was received from the State of Wisconsin for reimbursement of 51.8% of the cost of the victim/witness program of the District Attorney's Office. The District Attorney's office also received \$3,891.65 in restitution surcharges. Other than those sums, no monies or funds were received for fines, penalties or other costs.

The attached constitutes the balance of the report for the Office of the District Attorney for Marquette County.
